Each year our Honours and Awards catalogue is examined to ensure we are offering the kind of support our family physicians need most to improve the health of all Canadians and the ways in which they deliver care. With this in mind, we are thrilled to announce the 2016 additions to our program:

The Northern, Rural, Remote Family Practice Marco Terwiel Award. Family physicians in rural and remote areas are often innovators. Since they are frequently the only physician available for many miles around, their training has to be exceptionally broad and flexible if they are to respond

effectively to medical challenges that in other settings would be referred to emergency rooms or specialists. Out of necessity, family physicians practising in these situations generate novel ways to provide the high standard of care they are trained to deliver. Supported by the Research and Education Foundation of the CFPC and the Terwiel family, this award is for family physicians who have introduced effective and efficient ways to serve the medical needs of their communities. Janus Faculty Development Grants. Janus Faculty Development Grants support CFPC members who are involved in family medicine education in Canada. In 2015, the CFPC released Fundamental Teaching Activities in Family Medicine: A Framework for Faculty Development (FTA). The document outlines three domains that describe common teaching roles: clinical preceptor, teacher outside the clinical setting, and educational leader. The Janus Faculty Development Grants support CFPC members who are actively advancing their own abilities or developing and supporting the abilities of others in one or more of these three domains. Applicants must clearly describe the tasks and/or activities outlined in the FTA Framework for which they plan to use the funding. Applications are due February 16, 2016. The REF Board Governance Restructuring Plan

The CFPC is currently in a period of transition. While the Research and Education Foundation (REF) is incorporated separately, it exists to serve the CFPC and its membership. Both the REF board and CFPC senior staff recognize that for the REF to take its performance to the next level, it requires a plan and structure for governance that will best support its mandate and governance needs. The recent process used to restructure the CFPC board led many to think the REF would benefit from the same kind of discussion.

The REF has been on a path of growing success, having raised more than \$1 million in each of the past 3 years

to support more than 200 awards, grants, scholarships, and initiatives. To build on this momentum, higher fundraising targets have been set to support greater opportunities for research and education in family medicine. The REF board and CFPC senior team are strongly committed to raising funds to recognize and support the research and education initiatives of family physicians in their pursuit of the best health for the population.

The current REF board has agreed to create a smaller, skills-based board with directors who, together, are experts in the fields of governance, fundraising, and Canadian family medicine. The reasons identified for going to a smaller, skillsbased board include:

- To be more nimble and agile
- To increase board engagement and commitment
- To use other ways to engage our geographically dispersed
- To support a skills-based, versus a provincially representative, board
- To make the best use of resources

We look forward to sharing more of our governance restructuring process with you as the year progresses!
