



THE INSPIRATION BEHIND **OUR NEWEST AWARDS**

The Research and Education Foundation (REF) is proud to offer a wide range of awards, grants, and scholarships supporting and acknowledging family doctors at every stage of their career. This year, we had the pleasure of introducing the Daniel Glazier Award in Adolescent Mental Health and Substance Abuse, the Bruce Halliday Award for Care of the Disabled, and the Health Disparities in Outer City Communities Resident Award (in collaboration with the Ontario College of Family Physicians [OCFP]). Each of these awards was established by a College of Family Physicians of Canada (CFPC) member who was inspired by a life-changing situation, and we'd like to share their stories with you.

The Daniel Glazier Award in Adolescent Mental Health and Substance Abuse

Once a month, CFPC President, Dr Sandy Buchman gets together with a group of nearly a dozen male family doctor friends who lend support to one another. Almost two years ago, one of these friends, a long-time CFPC volunteer, committee member, and Chair, Dr Rick Glazier, lost a teenage son, Daniel, to an accidental overdose. Dr Buchman and his circle of friends struggled with how to help Dr Glazier and his family heal and with how to address insufficient research and a lack of physician resources and clinical tools to treat mental health and addiction problems in adolescents in Canada. As all are family doctors—and active members of the CFPC—the group came up with the idea of establishing an award to support their colleagues working to change this situation. Importantly, they added the name Daniel Glazier to the award to give it a face. Family and friends came together, generously contributing to establish this award for many years to come. The first award was presented at the 2011 Board Dinner in Montreal, Quebec.

The Bruce Halliday Award for Care of the Disabled

On January 1, 2011, family medicine lost a leader; Dr Bruce Halliday of Tavistock, Ontario, passed away at his home with his wife Elizabeth and his family at his side. To quote his hometown newspaper, The Sentinel-Review: "Whether it was his patients, his constituents or his community, Dr Bruce Halliday was known as a man who cared." He was an outstanding parliamentarian, serving almost 20 years as the MP for the Oxford Riding. He was an exceptional family doctor and received the Family Physician of the Year Award in 1975. Most dear to his heart was the care of the disabled. His first wife, Janet McGhie, contracted polio early in their marriage and died in 1983. As a result, Dr Halliday became a lifelong champion of and advocate for the disabled, chairing the House of Commons Standing Committee on Human Rights and the Status of Disabled Persons. It was not long after Dr Halliday's death that Dr Reg Perkin, past Executive Director of the CFPC, initiated a move to establish an award to advance the care of those living with disabilities that would perpetuate and honour the life and work of Dr Bruce Halliday. Dr Perkin recruited a cross-Canada group of Dr Halliday's friends and colleaguesmade up of Dr Brian Hennen, Dr Don Butt, Dr Moira Stewart, Dr Ken Hook, and Ms Jan Kasperski, the Executive Director of the OCFP-to help raise awareness and funding. Bruce's wife, Elizabeth Halliday, made a significant initial contribution to start the fund. Dr Perkin and his group have been busy soliciting support from members of the CFPC to present and past members of the Senate and House of Commons of Canada, and other contacts from Dr Halliday's community involvement. Some success has been achieved already and the work is ongoing. The motivation is strong to ensure a lasting legacy for the life work of this outstanding family physician and dedicated servant of the Canadian people.

Health Disparities in Outer City Communities Resident Award

The Jane-Finch neighbourhoods of Toronto, Ontario, have some of the worst health statistics across the country, including high infant mortality and chronic disease rates. In addition to being a low-income area, they have some of the lowest support services to meet their needs. When the community was about to lose their most significant health resource, the local community hospital, some faculty members from the Department of Family and Community Medicine at the University of Toronto took action. They created the Health Disparities in Outer City Communities Resident Award to support resident-led research that contributes to the reduction of health disparities in Toronto's outer city communities. The objective of this award is to bring two key elements to finding a solution: 1) the involvement and attention of health care providers and 2) a better understanding of the issues at hand.
