New Year - New Awards

As the Research and Education Foundation (REF) grows, so too our Honours and Awards Program expands to meet the needs of our members and their patients across Canada. We are especially pleased to announce four new awards appearing in our 2015 awards catalogue:

The Patient's Medical Home (PMH) 60/20 Caring and Compassion Grant, established with matching funds from Associated Medical Services. Caring and compassion are fundamental attributes that the CFPC (College of Family Physicians of Canada) wants to recognize and promote within PMH practices. The CFPC's PMH practice model embraces Canadian values of equity, fairness, and access to care for all people. Within a PMH, a team or network of family physicians and other health care professionals work together to provide and coordinate a comprehensive range of medical and health care services appropriate to the needs of that practice's patients and the communities it serves. Grants will be awarded to individuals or groups that undertake projects aimed at illuminating the caring and compassion taking place within PMH practices.

Patient Education Grants for Family Medicine Residents, established with funding from Scotiabank. The Patient Education Grants for Family Medicine Residents encourage these residents to become involved in the planning of patient education including development of resources. The grants recognize and support residents who take on projects during their training such as research; the development of learning tools; the creation and promotion of materials, tools, and presentations specifically addressing gaps in patient education resources; and the updating of existing information.

Power of the Arts in Family Medicine Fellowship, established with matching funds from the Michaelle Jean Foundation. Research on the arts as a tool for social inclusion, for innovation, for building healthy communities, and for strengthening active citizenship is key to developing, testing, and evaluating new initiatives and program models, which can then be refined and replicated nationally. The

arts can affect the prevalence and impact of social determinants of health. The Fellowship will support individuals or teams who are engaged in research related to the inclusion of arts in family practice, at the individual or community level, as a means to foster social inclusion, recovery, health, and well-being.

The Jim Ruderman Family Medicine Leader and Mentor Award, established with funding from Dr Ruderman's colleagues at Women's College Hospital. This award is named in honour of Dr Jim Ruderman, Chief of Family Medicine at Women's College Hospital, Toronto, Ontario, from 1992 to 2014—two of the most turbulent and rapidly changing decades in the specialty of family medicine and in the health care system. The award will recognize an outstanding family physician who embodies those qualities that have made Dr Ruderman such an outstanding leader—wisdom, equanimity, compassion, an eye for talent, and the capacity to attract and mentor talented individuals and to forge them into a dynamic and productive team.

Exploring the Arts and Humanities in Family Medicine

At Family Medicine Forum (FMF) 2014 in Quebec City, a collaborative art project called Open Studio was presented by Saskatchewan-based artist Jeff Nachtigall. Originally created as a program that offered marginalized individuals the opportunity to express themselves visually, this model has been successfully implemented in several communities across Canada. This hands-on theatre was open throughout FMF, and members participated and watched as the piece grew into a largescale work of art that showcased the raw energy, passion, and collective creativity of the family medicine community. Open Studio was funded through the generous donations of the Michaëlle Jean Foundation and Associated Medical Services to the Research and Education Foundation of the College of Family Physicians of Canada.
