Women's Health **Scholarships**

For almost a decade the Foundation for the Promotion of Sexual and Reproductive Health, an initiative of the Society of Obstetricians and Gynaecologists of Canada, has supported scholarships in Women's Health. These scholarships have benefitted members of the College of Family Physicians of Canada (CFPC) committed to enhancing their knowledge and skills to meet the needs of their communities.

Women's Health Scholarships have a powerful effect. They enabled Dr Avaleen Vopicka of London, Ont, to spend 20 half-day sessions in the Sexually Transmitted Infection Clinic at the Middlesex Health Unit. There she became skilled in using microscopy to aid in diagnosis. Dr Vopicka brought this skill back to the Family Planning Clinic where she works and has been teaching it to her colleagues, residents, and other members of her health care team.

Dr Suzanne Roberts of Saint John, New Brunswick, wanted to return to family practice obstetrics. Her scholarship allowed her to be on call with a family physician for 24 hours a few times a week for a 7-week period. During this time, she attended 36 deliveries, managed labour, and was able to determine when an obstetrical consultation was necessary. Dr Roberts now practises obstetrics with confidence and has become a member of a family practice maternity call group.

Dr Anthony Fong of Vancouver, BC, used his Women's Health Scholarship to become more aware of cross-cultural challenges in obstetrical care of Aboriginal populations. He has updated his skills in counseling during antenatal care, and these enhanced communications skills enable him to assess parents' knowledge and inform and reassure parents when appropriate.

There are many other success stories emerging from the Women's Health Scholarship

program. With the support of our partners and donors, our family doctors are making a difference in the lives of their patients.

Tax-free savings accounts—a smart concept for donors

Since 2008, Canadians 18 years old and older have been able to contribute up to \$5000 each year to a tax-free savings account. While contributions are not tax deductible, investments and withdrawals can be made on a tax-free basis. How does this relate to charitable giving? You could consider setting up a tax-free savings account with a charity named as the beneficiary. As the savings grow, you can enjoy tax-free withdrawals to make donations and use the receipts to lower your annual income tax bill. When you pass away, the account closes and the balance is directed to your designated charity. This has the added benefit of reducing estate taxes and leaving a little something more for vour loved ones.
